Update on share buy-back programme ForFarmers

ForFarmers N.V. (ForFarmers) has repurchased 109,771 shares in the period from 4 May 2020 through 8 May 2020.

The shares were repurchased at an average price of €5.92 per share, for a total amount of €649,331. These repurchases were made in accordance with the authorisation granted by the ForFarmers Annual General Meeting (AGM) of Shareholders on 24 April 2020 to complete the current share buy-back programme, as announced on 3 May 2019, for a total amount of €30 million. Also, from 29 April 2020, treasury shares were purchased for the employee participation plans for 2020, as announced in the press release on 24 April 2020 with regard to the decisions of the AGM.

The total number of shares that has been repurchased to date according to these programmes is 4,511,350 shares, for a total amount of €27,790,059.
